U. S. real gross domestic product grew at a 5.0 percent annual rate during the third quarter of 2014 and was 2.7 percent higher than in the third quarter of 2013.

Total civilian employment for the third quarter of 2014 rose 1.5 percent compared to 3Q2013 while the labor force grew by 0.3 percent. This caused the unemployment rate to drop from 7.3 percent in 3Q2013 to 6.1 percent in 3Q2014.

A survey of professional economists by the Federal Reserve Bank of Philadelphia projects the U.S. economy to grow 2.2, 3.0, 2.9, and 2.7 percent in 2014, 2015, 2016, and 2017, respectively.

An alternative set of forecasts by Wells Fargo Bank expects gains of 2.4 percent, 3.1 percent, and 2.9 percent for 2014, 2015, and 2016.



Total state employment for the third quarter of 2014 rose 0.2 percent from the previous quarter and was 2.0 percent higher than in the third quarter of 2013.

The unemployment rate for the third quarter was 5.7 percent, compared to 6.2 percent a year ago. The state unemployment rate was below the 6.2 percent national rate.

State sales tax collections for the third quarter fell 8.2 percent compared to the prior quarter and were 3.2 percent higher than for the third quarter of 2013. (On a year-over-year basis, the rise is a continuation of the growth noted during the recent quarters.)

Seasonally-adjusted state personal income increased 0.9 percent (\$1.8 billion) in the third

quarter of 2014, the 23rd largest percentage increase in the nation. Net earnings were up \$1.1 billion, dividends, interest and rents increased \$267 million, and personal transfer receipts increased by \$465 million.

Farm earnings were down \$364 million from 3Q2013.

Non-farm industries contributing the most year-over-year growth in earnings from 3Q2013 to 3Q2014 were "Construction" (+\$1.46 billion) and "Health Care and Social Assistance" (+\$887 million).

Non-farm industries showing year-over-year declines in earnings were "State and Local Government" (-\$626 million) and "Management of Companies and Enterprises" (-\$332 million).






Northshore Employment

Total employment in the Northshore Region (the five parishes of Livingston, St. Helena, St. Tammany, Tangipahoa, and Washington) was 1.1 percent higher in the third quarter of 2014 compared to the previous quarter, and rose 2.7 percent (8,082 jobs) compared to the same period in 2013.

The total civilian work force was 2.2 percent higher than the previous quarter and 2.6 percent higher than in the third quarter of 2013.

The unemployment rate for the third quarter of 2014 was 6.0 percent, compared to 5.0 percent in the previous quarter and 6.2 percent during the third quarter of 2013.

(Note: All regional and parish employment analyses are based on unadjusted employment data. Seasonally-adjusted data are not available at the parish level.)





The 3Q2014 value of retail sales for the region fell 2.7 percent from the previous quarter but was 6.1 percent higher than for the third quarter of 2013.


All five parishes in the Northshore region saw gains in sales compared to the third quarter of 2013.

Residential Building Permits in the Northshore Region

Building permits for residential units in the Northshore region for the third quarter of 2014 fell 9.2 percent over the prior quarter and were 15.6 percent lower compared to the third quarter of 2013.

On a year-over-year basis, St. Helena Parish showed a significant increase in building permits

(+175 percent) while the other four parishes reported declines.



Livingston Parish

Livingston Parish employment rose 1.2 percent over the prior quarter and grew 3.8 percent compared to the third quarter of 2013.

The unemployment rate of 5.4 percent was higher than the 4.4 percent in the prior quarter but less than the 5.5 percent of a year ago.

Initial and continuing unemployment claims in Livingston Parish were down 10.0 and 9.4 percent, respectively, compared to 3Q2013.

The value of taxable sales rose 8.4 percent compared to the third quarter of 2013, a higher rate of growth than that of the region (6.1 percent).

The number of homes sold in Livingston Parish was up 11.3 percent compared to 3Q2013, and median selling prices for July, August, and September 2014 were 3.6, 8.2, and 3.9 percent higher than the same months in 2013.

Foreclosure actions were down 11.8 percent from 3Q2013.







St. Helena Parish

Employment in St. Helena Parish in the third quarter of 2014 rose 3.8 percent compared to the same quarter in 2013.

The labor force rose only 1.6 percent, causing the unemployment rate to decline to 9.5 percent from 11.4 percent in the third quarter of 2013.

Initial unemployment claims and continuing weeks claimed were down 34.6 and 33.8 percent, re-

spectively, compared to 3Q2013.

The estimated value of taxable retail sales rose 6.3 percent compared to the third quarter of 2013, approximating the gains for the region.

Building permits for residential units rose 57.1 percent from the previous quarter and were 175 percent higher than in 3Q2013.





Total employment in St. Tammany Parish in the third quarter of 2014 rose 2.5 percent compared to 3Q2013, slightly below the average increase for the region (+2.7 percent).

The workforce increased 2.6 percent compared to 3Q2013, leading to a small increase in the unemployment rate to 5.3 percent.

Building permits issued for residential units fell 5.9 percent from the third quarter of 2013.





Weekly Initial Unemployment Insurance Claims









Total employment in Tangipahoa Parish in the third quarter of 2014 grew 1.7 percent compared to the third quarter of 2013.

The workforce rose 1.4 percent, causing the unemployment rate to fall to 7.4 percent from the 7.7 percent of a year ago.

Initial unemployment claims and continuing weeks claimed were down 21.9 percent and 12.5 percent, respectively, from 3Q2013.

The value of taxable sales rose 5.9 percent com-

pared to the third quarter of the previous year, slightly trailing the 6.1 percent average for the region.

Building permits were 9.5 percent lower compared to the third quarter of 2013, reflecting a subdued outlook for residential construction activities.





Weekly Initial Unemployment Insurance Claims





Weekly Initial Unemployment Insurance Claims







Healthy Collaboration

Southeastern's College of Nursing and Health Sciences recently launched a program with North Oaks Health System in Hammond to reduce the number of patient readmissions to the hospital. As part of the program, Southeastern students and local health care professionals are being trained to provide follow-up consultation with patients after they are discharged.

According to Dr. Ralph Wood, professor of health education and promotion, Southeastern is the only university in Louisiana providing this level of training to undergraduate students.

The Health Transition Alliance program trains the health coaches to work with diagnoses of heart attack, chronic obstructive lung disease, congestive heart failure and pneumonia. The program is funded by a three-year \$351,989 grant from the U.S. Department of Agriculture.

The students and other health coaches ensure discharged patients are following their physicians' instructions for home care, including taking medications, following a prescribed diet, using appropriate therapies and scheduling follow-up visits with their physicians. The majority of the patients have been receiving personalized health coaching in their own homes.

The Centers for Medicare and Medicaid estimate readmissions cost an estimated \$17 billion annually. The health coaching program is being studied by local economic development organizations to show how it could save millions in lost revenue, as well as create future employment positions in the field of health coaching.
